**BREEDING CONTRACT**

This stallion breeding contract for the breeding season of 20\_\_\_\_\_ is made and entered into on the \_\_\_\_\_ day of \_\_\_\_\_ 20\_\_\_\_\_, by and between Borrego Valley Ranch and \_\_\_\_\_, hereinafter designated as Mare Owner. Borrego Valley Ranch agrees to breed the mare \_\_\_\_\_ Registration # \_\_\_\_\_ **By transported cooled semen or fresh semen** to the stallion "Skip Legacy", AQHA Reg. # 3250655 or "Quincys Gold Devil", AQHA reg. #5078969 are subject to the following conditions:

**Breeding Privilege and Charges:** Mare owner agrees to pay the stallion service fee of **\$500**. A nonrefundable **\$250** booking fee is to be paid for reserving the above named stallion upon execution of this agreement. A copy of the mare's registration papers must accompany this agreement. The remaining **balance** is due and payable prior to the shipment of semen. In addition there will be a semen collection fee of **\$100**. Disposable shipping containers are **\$30**. Over night shipping, **at cost**. Equinetainers will require a **\$300 deposit**. These charges will apply on each semen shipment. Semen will not be shipped until all fees are paid. Last minute collections fee of **\$50**. Airport drop-off charge **\$150**.

**Waiver of Liability:** The above applies to the normal breeding period, which is understood by both parties to be from February 15 to August 15 for the breeding year. If the mare should fail to settle, the Mare Owner has the option to substitute another mare approved by Borrego Valley Ranch during the current season or have a return for the following season. Collection and shipment fees also apply to a replacement mare. If said stallion should expire, be sold by Borrego Valley Ranch, or become unfit for service prior to settling the mare, the service fee, including the booking fee, shall be refunded if it has been paid to Borrego Valley Ranch, thereby canceling the entire contract.

**Live Foal Guarantee:** Borrego Valley Ranch offers a live foal guarantee. "Live Foal" is defined as a foal that stands and nurses without assistance after foaling. Borrego Valley Ranch must be notified within seven days that the foal did not stand and nurse, or that no live foal will be produced from the Mare Owner's mare. Mare Owner then has the privilege to return during that breeding year or the following breeding year.

**Certificates and Conditions:** Mare Owner and Borrego Valley Ranch agree to ship/handle semen appropriately. For a shipment of semen the Mare Owner shall contact Borrego Valley Ranch at first detection of heat in the above named mare. Mare owner shall contact Borrego Valley Ranch before 10:00 a.m. PST for next-day shipment. There will be no pick up on Saturdays or Sundays. Borrego Valley Ranch requires a twenty-four hour notice for a semen shipment request. Collections are done once daily: Monday thru Saturday. A breeder's certificate will be issued for the foal, conceived by this mating, when the stallion fee and all other expenses have been paid in full and when the mare has produced a live foal by this mating. This contract is non-transferable and non-assignable. No cash refunds will be given. This contract is entered into in the State of California and will be interpreted and enforced under the laws of California. If any clause in this agreement is against State Law, then that clause will be null and void.

- The Purchaser will:**
- Determine heat cycle and best insemination dates.
  - Advise Stallion Owner when semen will be required.
  - Use a Veterinarian or Breeding Technician for insemination.
  - Inseminate only the designated animal.
  - Notify Stallion Owner of time and date of insemination.
  - Notify Stallion Owner of pregnancy check at 16-21 days.
  - Complete all required forms in a timely manner.
  - Pay all fees required for shipped semen registry; such as, DNA testing, parental verification, additional registration, etc.

When Stallion Owner and Purchaser sign this contract, it shall be binding on both parties, subject to the above terms and conditions.
